You grab extra blankets from around the house to ensure that everyone stays warm tonight. Payday is only a week away...

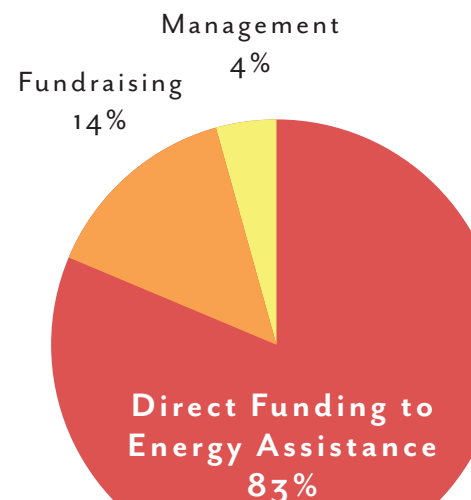
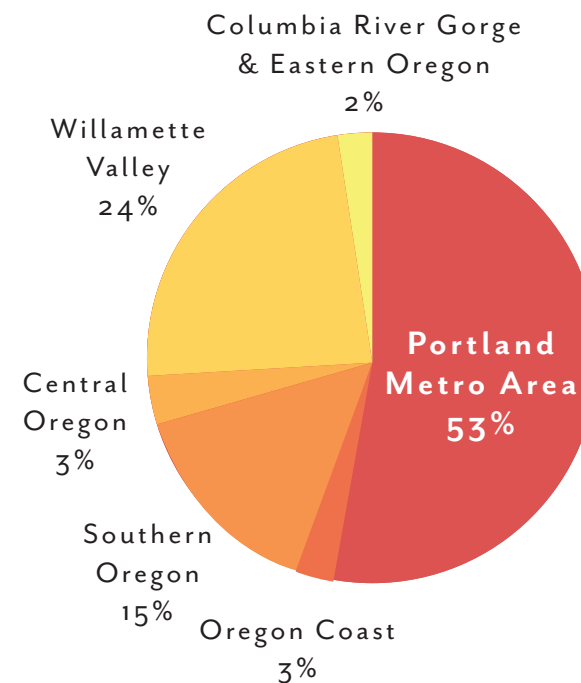

This number is even higher for households of single mothers & children.

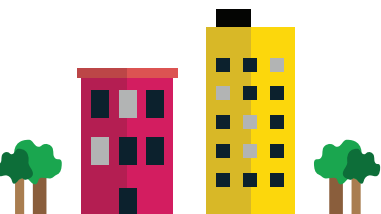
